How to Complete Your Family Tree

This chart documents your direct bloodline to your European ancestor. To ensure your application is processed correctly, please follow these instructions:

The Two Sides of the Tree

For every generation, there is a **Continuing Side** and a **Supporting Side**

:

The Continuing Side (Connecting Lines): Use the frames that are connected by vertical lines to the generation above. In these frames, enter the parent who carries the direct bloodline to your European ancestor.

The Supporting Side (Ending Lines): Use the frames where the lines do not continue upward for the spouse (the other parent) who is not part of the direct lineage being tracked.

The Path to Citizenship

The Bottom Frame: Enter your own details here (The Applicant).

The Middle Row: Enter your parents. Place the parent through whom you are claiming citizenship in the frame that connects to the row above.

The Upper Rows: Continue this pattern. Always place the direct ancestor in the frame that links to their parents (your grandparents and great-grandparents)

Required Information

Please fill out every frame completely with the following:

Name: Full legal name as it appears on official documents.

DOB: Date of Birth.

DOM: Date of Marriage.

Note to Client: Accuracy is vital. Please ensure that the names and dates match your supporting certificates (birth, marriage, etc.) exactly. If a specific date is unknown, please consult with us before finalizing the form.


